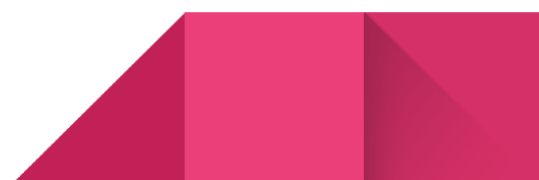

Flu Shot Reminder

New York State and ISMMS **mandate** that all students receive a flu vaccine. Remember that flu can mimic signs and symptoms of COVID-19. Furthermore, co-infection with flu and COVID-19 can lead to worse outcomes. By getting vaccinated, you protect yourself, your loved ones, and your community! There are plenty of options of where to obtain your flu vaccine.

- 1) Mount Sinai will be providing flu vaccines at local places of distribution (PODs) across the Mount Sinai campus and at local offices by appointment only. Please sign up [here](#) to schedule an appointment.
- 2) For students who are off-campus or remote, flu vaccines are readily available in local pharmacies and primary care offices.
- 3) Flu vaccines will be provided on floors of the Mount Sinai Hospital for teams working in those units.
- 4) You may schedule an appointment through MyChart to obtain a flu vaccine in Student Health. We cannot accept walk-in visits this year due to social distancing requirements.

- 5) The Employee Health [intranet site](#) and scheduling system will be updated with additional dates and times in the coming weeks.

In order to meet compliance requirements, please upload documentation of your flu vaccine [HERE](#). If you obtain the vaccine from student health or the student flu drive, you do not need to upload documentation. Remember to get your “21-FLU” sticker for your Mount Sinai ID once you provide documentation.

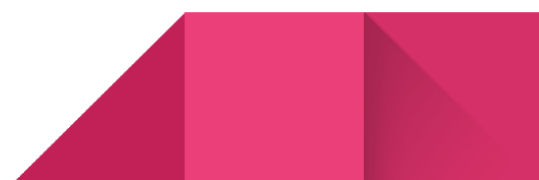

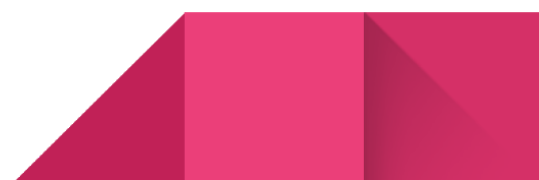

In 2020, she was named Chair of the Department of Global Health and Health System Design and Director of the Arnhold Institute for Global Health. She was recruited from Indiana University School of Medicine where she began as an assistant professor in 2008 and rose to Professor of Pediatrics and Director of Research in the Indiana University Center for Global Health and the Academic Model Providing Access to Healthcare (AMPATH).

Otolaryngology Interview Preference Signaling Program - Signals Due Oct 9

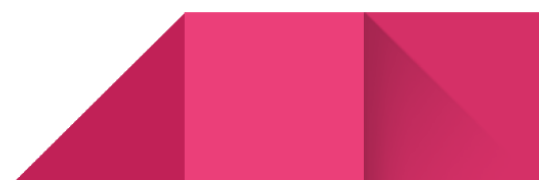

Applicants will submit their list of signals by October 9, 2020. Signals will be sent to programs around October 21, 2020. Programs will have signaling data available as they make decisions about interview offers. [Additional FAQs:](#)

- Each applicant will have the option to send 5 signals
- Applicants are not required to participate
- Signals should be sent between September 28 and October 9
- Applicants should NOT signal their home program or any program where you completed a Sub-I.
- A signal does not guaranteed an interview; alternatively not signaling a program does not mean you will not be offered an interview
- Signals are confidential

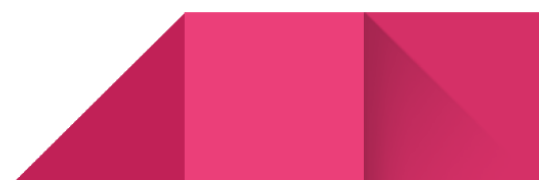

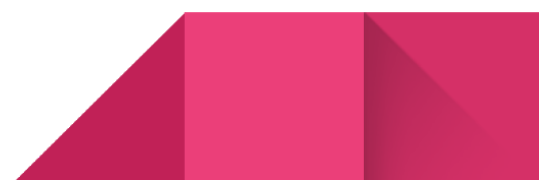

Decision Making in Year 3

During InFocus 6, Dr. Dweck spoke to you about how to use Year 3 as part of your decision making process and to think about how to identify your preferences for various aspects of the medical practice. In addition to the *Next 18 Months homework (due Monday)* which allows you to reflect on the year so far, the following are useful resources from the AAMC CiM website to assist you throughout your Year 3 journey.

Medical Specialty Preference Inventory (MSPI-R)

The [MSPI-R on the AAMC CiM website](#) uses an algorithm to compare you to and predict your likelihood of entering each of 16 specialties. It won't tell you what you will do, but can help guide you through your likes and dislikes.

Using your Clinical Rotations to Explore Specialties

“Clerkships are crucial for gathering information to make an informed specialty choice. You'll learn clinical skills associated with each specialty and begin evaluating how you feel about working with the patients, problems, procedures, and healthcare teams integral to their practice.

Do you want to:

- provide inpatient or outpatient care?
- work with different age ranges?
- work with one or both genders?
- provide diagnostic-oriented care or perform procedures? Or a little of both?
- see a wide breadth of patient problems or dive deep into a specific disease area or system?
- provide acute care or chronic, long-term care?
- interact directly with patients or indirectly?”



During your clerkships and elective rotations it is important for you to reflect on the above questions. You may also consider using the [Clinical Rotation Evaluation](#) to jot down your reflections on your rotations. Keep these in mind as you navigate your rotations and begin conversations with your various advisors/mentors. As a reminder and at this point in Year 3, students range from unsure - to deciding between a couple of specialties - to decision made. Wherever you are on this spectrum, these resources will help you along your decision making journey.

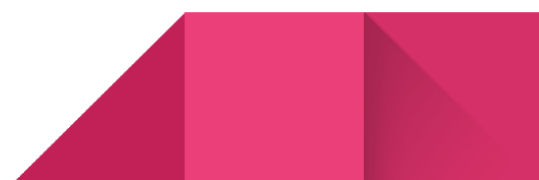

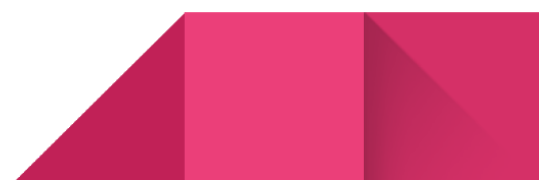
